

RUN THE NIGHT SERIES

2027 TEAM PACKAGES – TERMS & CONDITIONS (IRELAND)

These Terms and Conditions apply to the purchase of, and participation in, an official **Run the Night Series Team Package** (the *Package*) for the **2027 Run the Night Series** (the *Event*), owned and operated by **Catalyst Events** (*Catalyst Events, we, us, our*).

The person purchasing a Package (*Package Holder*) agrees to be bound by these Terms and Conditions.

These Terms and Conditions shall be read together with the Event **Participant Waiver**, **Event Rules**, and **Entry Terms and Conditions**, each of which applies to participation in the Event and is available on the Run the Night website.

1. PACKAGE PURCHASE

To participate in the Run the Night Team Programme, the Package Holder must purchase a Team Package through the official Run the Night registration platform.

Package pricing for the 2027 Event is as follows (all prices include applicable taxes and processing fees):

- **General Team Package:** €0
- **Titanium Team Package:** €195

Payment must be made in full at the time of purchase via the Event registration system.

All Team Packages:

- May not be transferred, divided, assigned, or shared with any third party without the prior written consent of Catalyst Events
- Must not be used in connection with any competition, promotion, prize draw, resale, or public offer without the prior written consent of Catalyst Events
- Are purchased by a single Package Holder, who shall remain solely responsible for all team administration and communications in relation to the Package

The Package Holder is responsible for the conduct of all team participants (*Team Members*) and for ensuring that all Team Members comply with these Terms and Conditions, the Event Participant Waiver, and any other applicable Event rules or instructions issued by Catalyst Events.

2. PACKAGE BENEFITS

Each Package includes benefits associated with the package level purchased.

General Team Package Includes:

- The ability to create and manage a team during Event registration

Titanium Team Package Includes:

- All General Team Package benefits
- **Centralised Race Bib Delivery:**
Race bibs will be posted to the address nominated by the Package Holder for Team Members who are fully registered and paid by **Friday 15th January 2027**
- **Team Results:**
A link to official post-event team results will be issued to the Package Holder
- **Participant Transfers:**
Person-to-person entry transfers at no additional cost up to **10th January 2027**
- **Team Name on Race Bibs:**
Available where Team Members are registered by **10th January 2027**
- **Pay Later via Invoice:**
Team Members may register without payment at the time of entry, with all applicable entry fees and charges invoiced directly to the Package Holder. All invoices must be paid in full within 5 days of the date of issue.

Additional services or benefits may be offered subject to availability and additional charges.

The Package Holder must comply with all reasonable and lawful instructions issued by Catalyst Events before, during, and after the Event.

3. REGISTRATION OF TEAM MEMBERS

Team Packages do **not** include Event entry fees. The applicable Event entry fee is €32 per participant.

Each Team Member must complete their own individual Event registration.

For Titanium Team Packages:

- Entries registered using the *Pay Later via Invoice* option shall be invoiced directly to the Package Holder
- The Package Holder is solely responsible for ensuring that all Event entry fees are paid in full prior to the Event
- No entry shall be deemed confirmed until full payment has been received

Catalyst Events shall not be responsible for errors made by the Package Holder when allocating registrations and reserves the right, at its sole discretion, to refuse refunds, credits, or replacements in respect of incorrectly distributed entries.

4. WARRANTIES & LIMITATION OF LIABILITY

To the fullest extent permitted by Irish law, all implied warranties, representations and conditions relating to the Package or Event are excluded, including any implied warranties relating to fitness for purpose or commercial benefit.

Nothing in these Terms excludes or limits any rights available under the **Consumer Rights Act 2022** or other applicable Irish consumer protection legislation that cannot lawfully be excluded.

Where liability cannot be excluded but may be limited, Catalyst Events' liability shall be limited (at its discretion) to one of the following:

- Re-supply of the Package
- Provision of a substitute package at a future Run the Night event
- Refund of the unused portion of Package benefits

5. EVENT CANCELLATION OR POSTPONEMENT

a) Event Cancellation

If the Event is cancelled in full:

1. Catalyst Events will notify the Package Holder as soon as reasonably practicable
2. Both parties will be released from further obligations relating to that Event
3. The Package Holder may elect one of the following remedies:
 - Transfer the Package to the same Event in the following year
 - Transfer the Package to a suitable alternative Catalyst Events event (subject to availability)
 - Receive a refund for the unused portion of Package benefits

b) Event Rescheduling or Relocation

Where the Event is postponed or relocated within the same general region:

- The Package remains valid
- No entitlement to termination or refund arises

c) Course or Schedule Changes

A reasonable modification to the distance, course, start time, venue layout, or individual sub-events shall not constitute a cancellation of the Event.

Except as expressly provided in these Terms and Conditions, Catalyst Events shall not be liable for any loss, cost, or expense arising from the cancellation, postponement, relocation, or modification of the Event.

6. RELEASE & INDEMNITY

To the extent permitted by Irish law, the Package Holder agrees to indemnify and hold harmless Catalyst Events and its employees, contractors, volunteers and agents against any claim, loss or damage arising from:

- Injury, death or property damage caused by the Package Holder or Team Members
- Breach of these Terms and Conditions
- Failure to comply with applicable laws or Event rules

Nothing in this clause shall exclude or limit liability to the extent that such liability arises from the negligence, fraud, or wilful misconduct of Catalyst Events, or where such exclusion or limitation is prohibited by law.

7. HEALTH & SAFETY

The Package Holder acknowledges responsibility for the health and safety of Team Members and agrees to comply with all applicable Irish health and safety legislation.

8. COMPLIANCE WITH LAWS

The Package Holder warrants that it will comply with all applicable Irish and EU laws and regulations in connection with participation in the Event.

9. INTELLECTUAL PROPERTY

No intellectual property rights are granted by the purchase of a Package.

Use of the **Run the Night, Catalyst Events**, or associated branding requires prior written approval.

10. GOVERNING LAW

These Terms and Conditions, and any non-contractual obligations arising out of or in connection with them, shall be governed by and construed in accordance with the laws of **Ireland**. The courts of Ireland shall have exclusive jurisdiction to hear and determine any dispute arising out of or in connection with these Terms and Conditions.

11. PRIVACY

By purchasing a Package, the Package Holder acknowledges and agrees that personal data may be collected and processed by Catalyst Events for the purposes of Event administration, safety, operational communications, and, where permitted by law, marketing, in accordance with the **Catalyst Events Privacy Policy** and applicable Irish and EU data protection laws, including the **GDPR**.

The Package Holder must comply with all applicable data protection laws when handling Team Member information.

12. EMAIL COMMUNICATIONS

By inviting Team Members via the Team Dashboard, the Package Holder represents and warrants that it has obtained all necessary permissions and consents required to contact those individuals. The Package Holder acknowledges and agrees that its name and email address may be visible to invited Team Members for the purposes of team administration and Event communications.
